# MEMORANDUM OF UNDERSTANDING BETWEEN MALLA REDDY INSTITUTE OF TECHNOLOGY AND SCIENCE AND INFOSEK

This agreement made and entered into on this 21-09-2019 between MALLA REDDY INSTITUTE OF TECHNOLOGY AND SCIENCE, Hyderabad situated At Medchal Road, Maisammaguda, Dulapally, Secunderaba, Telangana-500100 and Infosek office: 1st Floor Think Space Building, Street No:1, Patrika Nagar, Madhapur, Hyderabad-500081.

# The Parties to this Memorandum of Understanding (MOU) agree to the following:

## ARTICLE 1: PURPOSE AND SCOPE

- The purpose of this MOU is to provide best quality education to students through various activities such as technical training, workshops, fast-track course batches, & free internship training for shortlisted students.
- Technical training will be for a 3-4 Months (Academic session 2019-2020)
- Training will cover the entire course of Application Security at Rs 30000 per person.
- Infosek will conduct online /offline test for students. Also, the analysis of student's performance and result will be done by InfoSeK and would be submitting the same to college
- Infosek will provide 100% placement assistance after completing the Training program.
- Infosek will Conduct Two-day workshop on Application Security foundation and awareness, for which the dates will be decided by College for which the cost per student is Rs 1200.

# ARTICLE 2: CONDITIONS AND ARRANGEMENTS

- ❖ InfoSek will deliver a 2-Day workshop at college and would need Technical assistance from college (Projector, Mike, Seminar Hall and Student Coordiantors)
- ❖ Infosek would take interviews of the students who have attended the Workshop and shortlist students for Internship

- ❖ Infosek will require 50% AMOUNT for Internship training in 1<sup>st</sup>week of commencement and remaining 50% amount by start second month.
- For Internship Training, No. of students in each batch will be 15.
- ❖ Test will be conducted after completion of Internship training.
- ❖ Daily/Weekly attendance of students will be taken by the faculties of Infosek.
- ❖ Infosek will not provide notes in hard copies so only soft copies will be provided to students.
- ❖ Students who will be absent during training is not our responsibility and in such cases left out or backlog portion will not be covered.
- ❖ After completion of training certificates will be provided to every student.

#### **ARTICLE 3: TIMING**

- ❖ This MOU is valid for one year from the date of signing the proposal. i.e. upto 21-09-2020
- ❖ We can organize previously discussed activities for students every semester.

#### ARTICLE 4: FUTURE COOPERATION

\* We can sign this MOU every year based upon the performance of previous year, of both parties. The present MOU elucidates the general conditions and arrangements for future cooperation between the concerned parties. It is not legally binding on the parties. The exact terms and conditions of this future cooperation will be negotiated in due course and laid down in a contract, should circumstances permit.

## ARTICLE 5: NON-EXCLUSIVITY

The relation of the parties under this MOU shall be nonexclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or Collaborations of any kind. However, when entering into a particular research agreement, the Participants may agree to limit each party's right to collaborate with others on that subject.

#### ARTICLE 6: RELATIONSHIP

Nothing in this MOU shall be construed to make party a partner, an agent or legal representative of the other for any purpose.

### ARTICLE 7: ASSIGNMENT

It is understood by the parties herein this MOU is based on the professional competence and Expertise of each party and hence neither Party shall transfer or assign this Agreement, or Rights or obligations

arising hereunder, either wholly or in part, to any third party.

#### ARTICLE 8: SIGNED IN DUPLICATE

This MOU is executed in duplicate with each copy being an official version of the Agreement and having equal legal validity.
