A quick action committee is also a part of anti-ragging committee to respond on any ragging issues within no time to ensure the safety of newly admitted students.

The Committee members have taken measures to prevent ragging in our college and enforce protocols, steps to safe guard the newly admitted students. Senior students were made aware of the legal consequences of ragging and misconduct. Posters, Rules and regulations of Anti ragging are put up in and around the College area to generate awareness amongst Students on Anti-Ragging. Also the committee has emphasized on separate lunch break timings for I year students and senior class students. Further, signed undertakings are taken from students as well as parents/guardians with a mention that they won't indulge in the act of ragging.

The committee organized a seminar for senior students to create awareness among the students. The resource person for the seminar is Mr. B. Rambabu, Sub-Inspector of Police, Sector-IV In-charge, Pet Basheerabad. The legal procedures involved in ragging issues were discussed. The students were explained about the law of Anti-ragging. Senior students from II, III and IV year from all departments have participated in the seminar.
