- 3. Food quality, delivery time Some students pointed out that food quality has degraded over last few months. Also, service time has increased. It was suggested that a greater number of canteen workers and specialized cook would solve this problem.
- 4. Clean clothes, no tobacco chewing The canteen workers have to adhere to cleanliness and hygiene criteria mentioned in the contract which includes usage of clean clothes and no tobacco chewing in canteen area.
- 5. Suggestion/complaint register It was decided that a suggestion register should be kept in canteen to get regular feedback.
