

The Commission at its meeting held on 27.06.2023 has approved the recommendation of the Standing Committee on Autonomous Colleges to confer the autonomous status to **Malla Reddy Institute of Technology and Science, Dhulapally, Telangana affiliated to JNT University, Hyderabad** for a period of 10 years from the academic year 2023-2024 to 2032-2033 as per clause 7.5 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023.

The University, is therefore, requested to issue necessary notification within 30 days regarding the grant of autonomous status to the College as per UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023.

The autonomous college is required to abide by all the provisions of the UGC Regulations for Autonomous Colleges. The Regulations are available on the UGC website, www.ugc.gov.in. Non compliance of the requirements and conditions prescribed in the said Regulations shall attract action as per Clause -13 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023. The college should apply to University Grants Commission for extension of autonomous status atleast three months before the completion of autonomy period.



Non compliance of the above shall attract action as per Clause -13 of the UGC Regulations – 2023.
- (iii) The College/Institute is advised to take necessary steps for implementation of NEP 2020 and intimate the UGC.
